The licensee reported a missing package containing 13.62 MBq (368 uCi) of P-32. The package was being sent to the University of Illinois and the carrier was Federal Express (airway bill #646415995989). When the package did not arrive at the University by the expected date of 2/20/2004, the licensee requested a package trace. At that time, Federal Express indicated that the package was in Indianapolis, Indiana. An independent trace by the RSO of the Airway Bill was consistent with the information provided in that the package arrived at the Indianapolis Sort Facility on 2/20/2004. Federal Express searched their Indianapolis and Chicago, Illinois, sorting facilities with no positive results. As of 3/31/2004, the package remains unaccounted for. The activity level of the P-32 is now below exempt quantity.
