Pareez,

RAI 7.1-17 S01 was forwarded to you in an email from Lauren Quinones, dated April 24, 2007 (ML071760522). This email had a subject line of, "Supplemental RAI requests for sections 7.1 and 7.5".

This supplemental RAI requested the submittal for staff review of the licensing topical report NEDO-33295P, "ESBWR Cyber Security Program Plan" (proprietary), which is referenced in DCD Section 7.1.6.6.10.

Subsequent to the issuance of the supplemental RAI, GEH submitted MFN 07-143, dated June 1, 2007, which provides a schedule and commitments for the submittal of licensing topical reports and other technical data. This includes NEDO-33295P, "ESBWR Cyber Security Program Plan". GEH has also indicated that the schedule for the submittal of this report has been accelerated to October 31, 2007. Based on the GEH commitment to submit NEDO-33295P, "ESBWR Cyber Security Program Plan," RAI 7.1-17 S01 is resolved and no further GEH response is necessary.
