There is no safe level of radiation exposure.

Radiation exposure = dna damage= birth defects and cancers which are both increasing as I write this.

Government credibility on nuclear issues is nil. Mostly disinformation. Failed to adhere to any commitments and timelines.

There is no remedy for present nuclear contamination and nuclear byproducts.

There is no safe storage.

Rubber mats, vitrification, stainless steel, concrete for containment will all be gone long before the half life of the radioactive elements are expended.
