The purpose of this modification is to (1) exercise optional period one, thereby extending the period of performance from September 30, 2007 to December 31, 2007 and increasing the ceiling amount by \$21,450.00 from \$69,300.00 to \$90,750.00 (2) provide incremental funding in the amount of \$21,450.00, thereby increasing the obligated amount from \$69,300.00 to \$90,750.00. Accordingly, the contract is modified as follows:

1) Refer to Section B.2 entitled, "CONSIDERATION AND OBLIGATION—DELIVERY ORDER (JUN 1988), paragraphs (a) and (b) first sentence are deleted in their entirety and replaced with the following:

"(a) The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is \$90,750.00

(b) The amount presently obligated with respect to this contract is \$90,750.00."

2) Refer to Section B.3 entitled, DURATION OF CONTRACT PERIOD (MAR 1987) ALTERNATE 2 (MAR 1987), the first sentence is deleted in its entirety and replaced with the following:

"The contract shall commence on December 12, 2006 and will expire on December 31, 2007."
