The purpose of this modification is to provide incremental funding in the amount of **\$13,000**, thereby increasing the amount obligated by the Government under this contract from \$4,546,643 to **\$4,559,643**.

Accordingly, the contract is modified as follows:

1. Section B.4 is replaced with the following revised section B.4 CONSIDERATION AND OBLIGATION - COST PLUS FIXED FEE (JUN 1988)

"B.4 CONSIDERATION AND OBLIGATION--COST PLUS FIXED FEE (JUN 1988) ALTERNATE I (JUN 1991)

This clause applies only to CLINs 1, 2, 4, 5, 7, 8, 10, 11, 13, and 14.

(a) The total estimated cost to the Government for full performance of this contract is \$5,184,676, of which the sum of \$4,816,992 represents the estimated reimbursable costs, and of which \$367,684 represents the fixed fee.

(b) There shall be no adjustment in the amount of the Contractor's fixed fee by reason of differences between any estimate of cost for performance of the work under this contract and the actual cost for performance of that work.

(c) The amount currently obligated by the Government with respect to this contract is **\$4,559,643**. As of invoice No. **68** dated **8/7/2007**, there are cost recovery funds in the amount of \$625,033 under this contract, which are hereby applied to the cost appropriation of this contract. Therefore, the total funding obligated by the NRC and applied to the contract through cost recovery is **\$5,184,676**. Of this amount **\$4,191,959** represents the obligated funds earmarked for reimbursement of costs, **\$625,033** applied to the total estimated costs through cost recovery, and **\$367,684** represents the funds earmarked for the fixed fee.

(d) It is estimated that the amount currently allotted will cover performance through **September 30, 2007.**"
