The Nuclear Energy Institute (NEI) is pleased to submit these comments on Draft Regulatory Guide 1173 as noticed in the Federal register on June 28, 2007 (72FR35521). Overall we support this much needed updating of the Regulatory Guide and encourage the NRC to issue it after addressing the comments below.

1) Page 8 of DG 1173 states "Leakage Monitoring of Risk-Significant Areas in RCS - Critical components of the RCPB should be monitored for leakage." Please clarify the above recommendation to address whether indirect methods of monitoring the critical components of the RCPB are acceptable. For example, use of area radiation monitors to indicate potential component leakage.

2) NRC Inspection Manual, IMC 2515, Attachment 1, "Assessing Reactor Coolant System (RCS) Unidentified leakage Rate Trend," uses a statistical approach (based on an inventory balance) to determine unidentified RCS leakage action levels. How does this approach relate to the 'leakage detection instrumentation' action levels referred to throughout DG-1173? These two documents should be consistent; however, there is no indication that IMC 2515 was used as a developmental reference for the draft regulatory guide.


