Ladies and Gentlemen:

In August 2006, Southern Nuclear Operating Company (SNC) submitted an Environmental Report (ER) in support of the Vogtle Early Site Permit (ESP) Application. The ER contained a description of the alternative sites evaluated and the process used to develop the alternative site determination. In July 2007, the U.S. Nuclear Regulatory Commission (NRC) requested additional information on the process used to select the list of proposed sites subject to the screening process that determined the final candidate alternative sites. Thus, SNC is providing, in the enclosure to this letter, a summary of the preliminary selection process for the proposed sites to facilitate the development of the Draft Environmental Impact Statement (DEIS). An advance copy of this document was provided by email on August 1, 2007, per NRC request, to expedite development of the DEIS.
