Ladies and Gentlemen:

By letter AR-07-0887, dated May 3, 2007, Southern Nuclear Operating Company (SNC) submitted Revision 2 to the Vogtle Early Site Permit (ESP) Application to the U.S. Nuclear Regulatory Commission (NRC) requesting site approval for two additional reactor units at the Vogtle Electric Generating Plant (VEGP) site near Waynesboro, Georgia. In accordance with 10 CFR 52.17(c), the ESP application includes a site redress plan and requests that the ESP include authorization to conduct pre-construction activities described in 10 CFR 50.10(e)(1). However, based on subsequent discussions with the NRC regarding SECY-07-0030, *Final Rulemaking on Limited Work Authorizations*, SNC has supplemented the ESP application to also request that authority to perform selected construction activities described in 10 CFR 50.10 (e)(3) (LWA-2) be authorized. These LWA-2 activities generally involve placement of engineered backfill and preparation of the Nuclear Island foundation base slab forms and reinforcing steel. The enclosure to this letter contains revised and new, ESP application sections that have been modified to request the expanded LWA-2 activities. The revision numbers for the new, supplemented application sections have been changed to "2-S1" to distinguish them from their existing revision numbers.

This submittal has been prepared in accordance with existing regulations that address LWA activities as they apply to 10 CFR Part 52. It is SNC's intention to revise the ESP application to conform to the pending revisions to the NRC's regulations governing LWA once they have become final and effective.

This ESP application supplement does not contain restricted data or other defense information that requires separation from the unclassified information in accordance with 10 CFR 50.33(j) pursuant to 10 CFR 52.17(a)(1).


