SUBJECT:    REQUALIFICATION PROGRAM INSPECTION

Dear Mr. Wadley:

In a telephone conversation on August 2, 2007, Mr. Mark A. Walter, General Supervisor Operations Training, and Mr. D. McNeil, Senior Operations Engineer, made arrangements for the NRC to inspect the licensed operator requalification program at the Prairie Island Nuclear Generating Plant. The inspection is planned for the week of October 15, 2007, which coincides with your regularly scheduled requalification examination cycle. The staff at your facility should prepare and conduct the requalification examinations in accordance with your NRC-approved requalification program.

This letter contains information collections that are subject to the *Paperwork Reduction Act of 1995* (44 U.S.C. 3501 et seq.). These information collections were approved by the Office of Management and Budget, approval number 3150-0018, which expires on June 30, 2009.
