

The purpose of this modification is to exercise the optional period of performance for the period October 1, 2007 through January 31, 2010, to add optional subtask 2 in the amount of \$134,858, to increase the ceiling of the task order by \$134,858, and to provide incremental funding in the amount of \$10,380. Accordingly, the following changes are hereby made:

1. Section B - CONSIDERATION AND OBLIGATION-COST PLUS FIXED FEE (JUN 1988), Paragraphs "a" and "c" are hereby deleted in its entirety and replaced with the following:

"a. The total estimated cost to the Government for full performance of this task order is \$238,478, of which the sum of \$221,164 represents the estimated reimbursable costs, and of which \$17,314 represents the fixed fee.

c. The amount presently obligated with respect to this order is \$114,000 (\$30,000 of which was transferred from Basic Contract No. NRC-02-06-018 Award). The Contractor shall not be obligated to incur costs above this ceiling/obligated amount unless and until the Contracting Officer shall increase the amount obligated. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's sole risk."

2. Section C - PERIOD OF PERFORMANCE, is deleted in its entirety and replaced with the following:

"The period of performance of this task order shall be October 6, 2006 - January 31, 2010."

A summary of obligations under this order, from date of award through this modification, is given below:

FY06 obligation amount: \$30,000 (transferred from Basic Contract NRC-02-06-018
FY07 obligation amount: \$84,000
Cumulative total of NRC obligations to date: \$114,000

This modification obligates \$10,380 in FY07 funds.

All other terms and conditions of this task order remain the same.
