SUBJECT: RADIOLOGICAL CONTINGENCY PLAN REVISIONS (TAC L32649)

Dear Dr. Asmussen:

This letter is in response to the revisions to your Radiological Contingency Plan submitted by letter dated August 22, 2007. The revisions reflect changes to the emergency response organization names and telephone numbers of listed on-site and off-site emergency response and support personnel and agencies (revised Figures 41A and 41B), and changes to materials and locations of activities addressed by the Radiological Contingency Plan. We have completed our review of the submitted changes and have determined that the changes do not decrease the effectiveness of the Radiological Contingency Plan and thus, were properly submitted under the provisions of 10 CFR 70.32(i).

This letter closes activities related to TAC L32649.

The U.S. Nuclear Regulatory Commission (NRC) will incorporate a Revised Safety License Condition S-23 into your license when the next amendment is issued. Revised Safety Condition S-23 will read as follows:

S-23: The licensee shall maintain and execute the response measures described in the Emergency Plan dated October 10, 1997, and supplements dated November 6, 1997; October 1998; July 26, 2006; and August 22, 2007; or as further revised by the licensee consistent with the provisions of 10 CFR 70.32(i).
