Mr. Pethcik,

Two items are missing from the financial assurance instrument documentation submitted with your August 23, 2007 letter. They are the "specimen certificate of events" and the "specimen certificate of resolution to commence decommissioning". these documents are required as described on page A-62 of NUREG\_1757, volume 3. As described there, they should be unexecuted draft documents. You may submit the blank forms shown in appendix A, A.5.5 "Model Specimen Certificate of Events" and A.5.6 "Modelspecimen Certificate fo Resolution to Commence Decommissioning".

All other documents required by checklist 5-A are in your submission.

I have reviewed the Escrow Agreement, and all required information is in that document. I also have reviewed, and have no other questions about, the other documents required by the checklist.

Regarding your question for the updated Decommissioning funding Plan, these are required to be updated every 3 years, and if the cost estimate increases, the financial assurance instrument would have to be revised. Because your DFP is dated March 2007, I believe you are not required to update until 2010.
