Nuclear Information and Resource Service hereby responds to the motion by Shaw AREVA MOX Services requesting that NIRS be excused from participation in the above captioned proceeding.


NIRS did not intend any disrespect to the Atomic Safety Licensing Board, the other parties, or the proceeding itself, when on August 21, 2007 its representative, Mary Olson, failed to communicate, that due to unanticipated immediate medical circumstances she would be unable to attend either the public comment meeting in North Augusta that evening, or the pre-hearing oral arguments the following day. Ms. Olson did communicate directly (by phone) on the 21st with the representatives of Blue Ridge Environmental Defense League (BREDL) (Louis Zeller) and Nuclear Watch South (NWS) (Glenn Carroll). Ms. Olson presumed that BREL and NWS would be permitted to represent NIRS' interests in her absence, especially in light of the Licensing Board's June 14, 2007, order requiring that the intervenors' written reply should be "consolidated."

NIRS regrets that our misunderstanding of the Board's direction has created a situation

that is causing distress. We apologize. Ms. Olson had fully planned to attend and to participate in this proceeding, but was prevented by sudden illness from attending.

NIRS requests to remain a party to this process, and will do our utmost to conform to the relevant regulations governing this process.
