The purpose of this modification no. 2 is to exercise the option to extend the period of performance for four years as set forth below. Accordingly, the following changes are hereby made:

1. Page 1, Block 15A , lines 6 and 7 are revised to read: "Performance Period: September 29, 2006 - September 28, 2011". In addition, Block 15G is hereby revised to read: "\$802,505".
2. Section F.6, "Duration of Contract Period..." , First sentence is revised to read: "The ordering period for this contract shall commence on the date of award and will expire on September 28, 2011." The last two paragraphs of this section are deleted.

A summary of obligations for the subject contract is provided below:

FY06 Obligation Amount: \$15,000
