

The purpose of this modification is listed below:

- (1) In accordance with paragraph C.7 - Option to Extend the Term of the Contract, Option Year 3 under the subject contract is hereby exercised by the Government and shall be billed in accordance with the unit prices reflected under the Schedule of Supplies/Services. As a result, the period of performance of the subject contract is extended from September 1, 2007 to August 31, 2008.

- (2) Under Paragraph B.1 - **CONSIDERATION AND OBLIGATION-DELIVERY ORDERS** (JUN 1988), the first sentence of Subparagraph (a) and (b) are hereby deleted in their entirety and substituted in lieu thereof the following:

"B.1 CONSIDERATION AND OBLIGATION-DELIVERY ORDERS (JUN 1988)

- (a) The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is \$328,635.00. "
- (b) The amount presently obligated with respect to this contract is \$84,000.00."

3. Under Paragraph B.2 - **DURATION OF CONTRACT PERIOD (MAR 1987)** **ALTERNATE 4 (JUN 1988)** is hereby deleted in its entirety and substituted in lieu thereof the following:

"B.2. DURATION OF CONTRACT PERIOD (MAR 1987) ALTERNATE 4 (JUN 1988)

The ordering period for this contract shall commence on November 1, 2004 and will expire on August 31, 2008. Any orders issued during this period shall be completed within the time specified in the order, unless otherwise specified herein. (See 52.216-18 - Ordering). The term of this contract may be extended at the option of the Government for an additional two (2), one-year option periods."

NOTE: Page 8 of the Statement of Work which was incorporated under award of the basic contract as an Attachment, is also modified to reflect the revised period of performance as reflected above.
