Request for Additional Information Re: Byproduct Material License – Request for Amendment

Entergy Nuclear Operations, Inc. (ENO) submitted an amendment request for materials license 21-08606-03, held at the Palisades Nuclear Plant, on May 24, 2007. By conversation record dated August 16, 2007, the Nuclear Regulatory Commission (NRC) requested additional information. The responses to the requested information are provided below.

Please provide a copy of your certificates (or name inclusion in an official listing) confirming your CHP certification by the American Board of Health Physics and NRRPT certification by the National Registry of Radiation Protection Technologists as referenced in subject amendment request.

American Board of Health Physics certificate for Mr. David Nestle is enclosed. Per telephone conversation with Loren Hueter of NRC Staff, on August 23, 2007, NRRPT certificate is not required.

NRC Requested Information

*The May 24, 2007, amendment request notes a name change for the licensee, with one word differing from that shown in the letter head. Please clarify whether the second line should read "Palisades **Power** Plant" or "Palisades **Nuclear** Plant." Also, please clarify whether or not "**Memorial**" should be included in the third line of the licensee address, as it is not included in the current license.*

NRC Requested Information




