Dear Mr. Morse:

We have reviewed your application requesting an amendment to Materials License No. SNM-1511, dated February 9, 2007, and acknowledged by our letter dated February 21, 2007,

The U. S. Nuclear Regulatory Commission (NRC) staff has determined that the amendment application does not include all essential elements to enable an adequate safety review. Specific technical justification for our decision is discussed in the enclosure. The application deficiencies are based on the regulations in 10 CFR Parts 70 and 20. Because the application request does not include all essential elements, we will suspend our review. The application request may be resubmitted after the deficiencies have been addressed. We are willing to meet with you at a mutually agreeable time to discuss the deficiencies and any other issues related to your license amendment request. We recommend that we meet before you re-submit your amendment request.
