Dear Mr. Duncan:

This refers to the in-office inspection conducted on September 4, 2007. The purpose of the inspection was to verify that your program to transport or deliver to a carrier for transportation, items containing radioactive materials quantities of concern (RAMQC) has effectively implemented the additional security measures (ASM) imposed by U.S. NRC Order EA-05-007, "Imposing Additional Security Measures on the Transportation of RAMQC," issued July 19, 2005, and to verify that the Safeguards Information - Modified Handling (SGI-M) protection requirements specified in NRC Order EA-04-0191, "Imposing Requirements for the Protection of Certain Safeguards Information," issued November 5, 2004, have been successfully incorporated into your information protection strategy. At the conclusion of the inspection, the findings were discussed with members of your staff.

Areas examined during the inspection included physical security protection programs. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observation of activities in progress.

Based on the results of this inspection no findings were identified.

In accordance with 10 CFR 2.390 of the NRC's "Rules of Practice," a copy of this letter will be available electronically for public inspection in the NRC Public Document Room or from the Publicly Available Records (PARS) component of NRC's document system, ADAMS.
