For package situations, you will use a Form 665P, and make as many copies needed to complete the Document Sections per the number of documents to be processed and packaged. If you have documents that are already in ADAMS that need to be included in the package, the ML#s of those documents should be included on the form as well.

I will have the documents packaged and the package profile title will be "Plant Vogtle Documentation Received from DOE Savannah River Site". Docket numbers 50-424, 50-425 and 52-011 were handwritten on the form. PROJ0734 was what I included in the email as this is the docket number for Savannah River. We will only pick up docket 52-011 as you request.

Laura,

The Document Processing Center received a bunch of documents submitted under one 665 form, titled, **"Plant Vogtle Documentation Received from DOE Savannah River Site"**, for processing into ADAMS as Non-Publicly Available. We have been directed to process the documents as stand-alone documents following normal profiling standards. The documents will have their own individual titles based on information on the document.

Normally, stand-alone documents submitted under Form 665S that are added to ADAMS should each have its own 665 form filled out completely, and documents submitted under Form 665P to be packaged should have each Document section of the 665P completely filled out.

The DPC will complete processing of the documents as individual stand-alone documents that will not be packaged, set the Availability/Sensitivity as Non-Publicly/Non-Sensitive, and include docket numbers 50-424, 50-425 and PROJ0734 in the profiles. I noticed that you included docket 52-011 as well. Do you want this docket number picked up?
