SYNOPSIS

This investigation was initiated by the Nuclear Regulatory Commission (NRC), Office of Investigations (OI), Region II (RII), on August 16, 2006, to determine whether a former Security Officer, Securitas Security Services, Inc. (Securitas), employed at the Shearon Harris Nuclear Plant, was discriminated against for engaging in protected activity. The security officer's protected activity was relative to reporting a fitness-for-duty (FFD) issue to Securitas management on July 1, 2006.

Based on the evidence developed during this investigation, OI:RII did not substantiate that the former Security Officer, Securitas Security Services, Inc., was discriminated against for raising an FFD issue.
