This refers to your license amendment request. Enclosed with this letter is the amended license. The facility at 769 Northfield Avenue, Suite 130, West Orange, New Jersey may be released to Essex Cardiology Group concurrent with the issuance of its NRC license. Based on the information reviewed by Stephen Hamman of this office during an inspection on October 3, 2007, the information requested in a letter dated September 26, 2007, is no longer required. Specifically, the transaction was the dissolution of a partnership involving a buyout with no transfers of stocks or other assets. Mr. Hamman determined that no patient studies are being performed in Suite 130 until such time as the NRC license for Essex Cardiology Group is issued. Finally, all surveillance and quality control records are in the possession of Essex Cardiology Group.

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region I Office, Licensing Assistance Team, (610) 337-5239, so that we can provide appropriate corrections and answers.

An environmental assessment for this action is not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
