Reference Task Order 28, OIS Short Term Operational, Administrative, and System Support, under Delivery Order DR-33-07-358.

The purpose of this modification is to (1) increase the task order ceiling, and (2) add incremental funding, as follows:

1. OIS requires support for reviews of additional security document packages. Therefore, the ceiling of this task order is increased by \$124,205.44, from \$141,264.96 to \$265,470.40. A cost schedule for Task Order 28, dated January 28, 2008, listing labor categories, hourly rates, and hours, for a total ceiling amount of \$265,470.40, is attached.

2. Incremental funding is added in the amount of \$116,000.00, thereby increasing the obligated amount from \$109,393.80 to \$225,393.80.
