Reference Task Order 11, Database Administration, under Delivery Order DR-33-07-358.

The purpose of this modification is (1) to revise the Task Order 11 labor categories, hourly rates, and hours, (2) to decrease the ceiling amount, and (3) to add incremental funding.

1. Task Order 11 labor categories, hourly rates, and hours are revised to better reflect the effort required under this task order, at no additional cost to the NRC.
2. The ceiling of this task order is decreased by \$64.50, from \$541,002.47 to \$540,937.97. A cost schedule for Task Order 11, listing the revised labor categories, hourly rates, and hours, for a total ceiling amount of \$540,937.97, is attached.
3. Incremental funding is added in the amount of \$302,260.97, thereby increasing the obligated amount from \$238,677.00 to \$540,937.97, and fully funding this task order.
