BWX Technologies, Inc. (BWXT) is providing its response to the NRC letter dated March 31, 2008 (Reference #6) in regards to the NRC's final public disclosure determination of BWXT financial information that was submitted by letters dated November 14, 2007 (Reference #2) and January 7, 2008 (Reference #3).

BWXT appreciates the NRC's decision to withhold portions of Chapter 10 and other submitted information from public disclosure as described in letters dated February 1, 2008 (Reference #4) and March 31, 2008 (Reference #6).

BWXT has decided to not contest the NRC's final public disclosure determination stated in the Reference #6 letter, and respectively requests that the NRC proceed immediately with public disclosure of the SNM-42 license transfer information as determined in the Reference #4 and Reference #6 letters. BWXT has obtained permission from the U.S. Department of Energy (DOE) to also release information contained on Pages 10-i, 10-1, 10-6 and 10-7 of SNM-42 Chapter 10 that references the DOE program that was not listed as being approved for release in the Reference #4 and Reference #6 letters. Based on the Reference #4 and Reference #6 letters, BWXT understands that the following items in SNM-42 Chapter 10 will not be released: the individual cost estimates from each plant area contained in Table 10.3 on page 10-6, and all information contained in Appendices 10-2 through 10-7.
