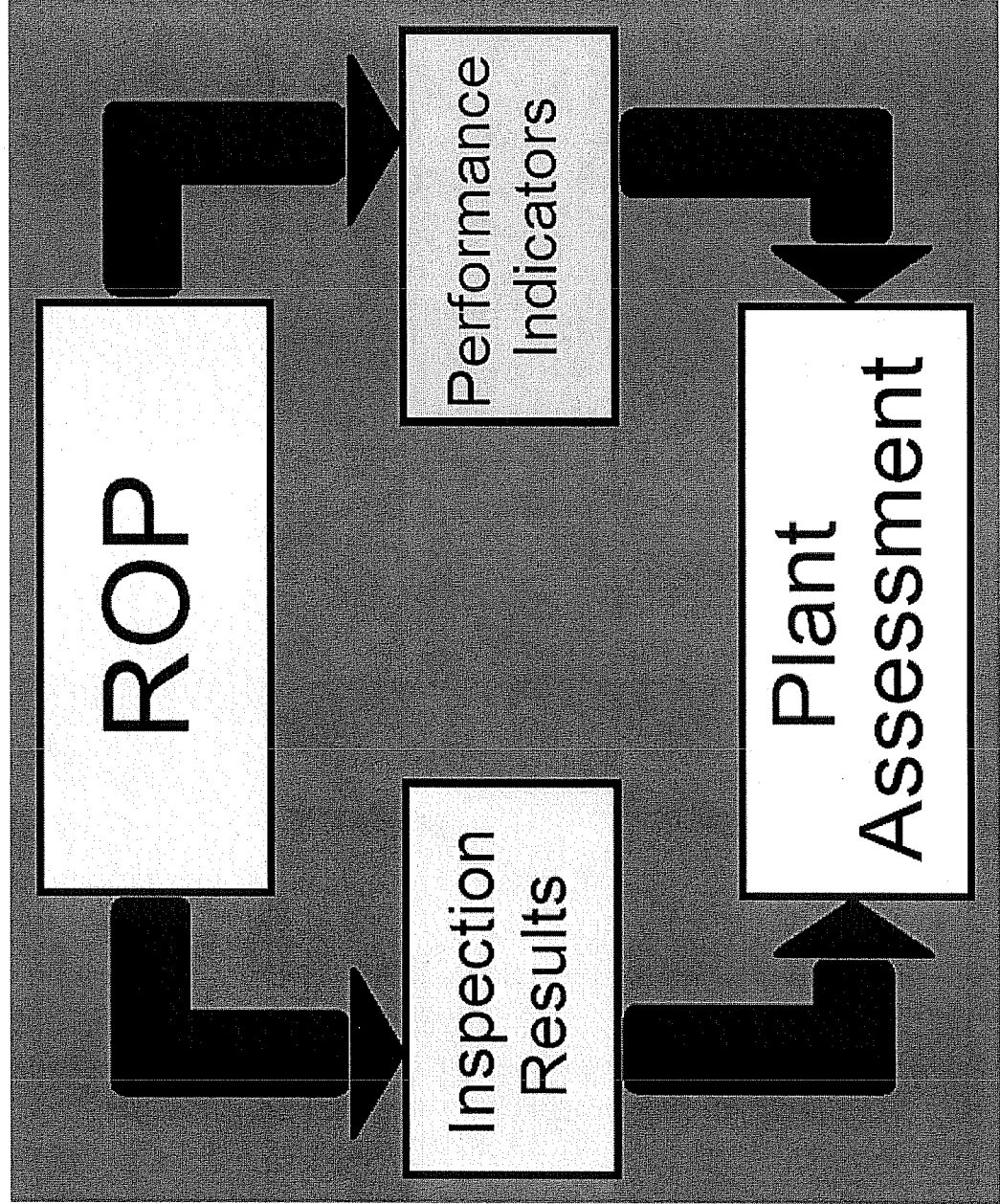


NRC Strategic Goals

Significance Thresholds

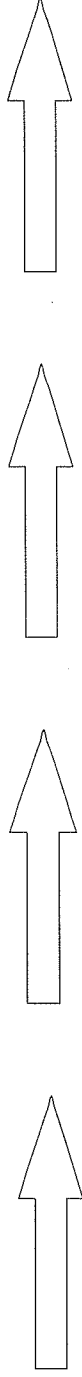

2007 Inspection Activities

- Baseline Inspection Program
- Special Inspection for loss of Instrument Air
- Event follow-up inspections
- Inspection to review falsification of fire watch rounds



Assessment Results

- San Onofre Generating Station was operated in a manner that preserved public health and safety and met all cornerstone objectives.
- Plant performance was within the Licensee Response column for both Units 2 and 3.



Substantive Crosscutting Issues

- Eight findings were identified with Problem Identification and Resolution aspects.
- Six Green findings resulted in a theme for the failure to thoroughly evaluate problems, including causes and extent of conditions.
- A performance improvement plan was developed, but full implementation of the corrective actions was not complete by the end of the inspection period.



Substantive Crosscutting Issues (cont.)

- Nine findings were identified with Human Performance aspects.
- Four Green findings resulted in a theme for failing to provide adequate procedures or work instructions.
- A performance improvement plan was developed, but implementation has not been effective in addressing this issue.



Confirmatory Order

- Issued January 11, 2008 as a result of alternative dispute resolution mediation session which occurred on December 3, 2007
- Involved falsification of firewatch rounds on numerous occasions from April 2001 – December 2006
- SONGS taking specific corrective actions to prevent recurrence of similar issues



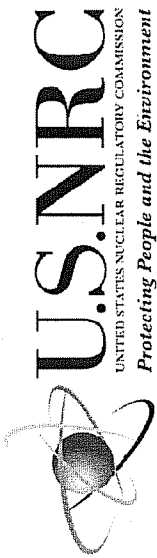

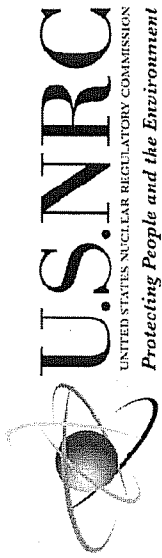
