Reference Task Order 16, Consolidated Publishing to NRC Web Site, under Delivery Order DR-33-07-358.

The purpose of this modification is to (1) increase the task order ceiling and describe the additional support required, (2) revise the price schedule, and (3) add funding, as follows:

1. Increase the ceiling of this task order by \$13,995.36, from \$130,334.32 to \$144,329.68. This ceiling increase is required to complete additional work requests from program offices such as redesigning office-level pages, providing new program specific web sites as instructed by Commission SRMs, and other ad hoc requests due to unanticipated Commission directed assignments and new initiatives.
2. Replace the existing price schedule with the attached revised price schedule, dated July 29, 2008, listing labor categories, hourly rates, and hours, for a total ceiling amount of \$144,329.68.
3. Add incremental funding in the amount of \$13,995.36, thereby increasing the obligated amount from \$130,334.32 to \$144,329.68, and fully funding this task order.
