Reference Task Order 15, SECY Tracking and Reporting Systems (STARS), under Delivery Order DR-33-07-358.

The purpose of this modification is to (1) increase the task order ceiling and describe the additional support required, (2) revise the price schedule, and (3) add funding, as follows:

1. Increase the ceiling of this task order by \$22,314.08, from \$71,685.22 to \$93,999.30. This ceiling increase is required to complete the following:

STARS is one of the NRC's legacy systems. The intent in the long term is to transition to the EDATS system. The EDATS team started efforts to put the Commission's Correspondence Tracking on the EDATS system and additional resources have been required to identify the data entry, data structures, and data tables used in STARS and which will be needed in EDATS after the transition.

2. Replace the existing price schedule with the attached revised price schedule, dated July 29, 2008, listing labor categories, hourly rates, and hours, for a total ceiling amount of \$93,999.30.
3. Add funding in the amount of \$23,999.30, thereby increasing the obligated amount from \$70,000.00 to \$93,999.30, and fully funding this task order.
