Reference Task Order 5, OCFO Fees Program Systems, under Delivery Order DR-33-07-358.

The purpose of this modification is to (1) increase the task order ceiling, (2) revise the price schedule, and (3) add funding, as follows:

1. Increase the ceiling of this task order by \$69,995.79, from \$456,431.70 to \$526,427.49. This ceiling increase is necessary to accomplish the requirements of this task order.
2. Replace the existing price schedule with the attached revised price schedule, dated August 14, 2008, listing labor categories, hourly rates, and hours, for a total ceiling amount of \$526,427.49.
3. Add incremental funding in the amount of \$96,270.00, thereby increasing the obligated amount from \$430,157.02 to \$526,427.02.
