Reference Task Order 29, Integrated Personnel Security System (IPSS), under Delivery Order DR-33-07-358.

The purpose of this modification is to (1) extend the period of performance of this task order, (2) increase the task order ceiling, (3) revise the price schedule, (4) replace the Statement of Work, and (5) add incremental funding, as follows:

1. The period of performance end date of this task order is extended from September 25, 2008, to September 25, 2009, an extension of one year, in order to continue the effort under this task order during option year one of Delivery Order DR-33-07-358. The revised period of performance is from September 26, 2007, through September 25, 2009.
2. Increase the ceiling of this task order by \$159,139.65, from \$144,723.80 to \$303,863.45. It is estimated that the ceiling allotted will cover performance of the effort for a nine-month period, through June 25, 2009. The ceiling may be revised by modification to this task order if and when additional ceiling is available.
3. Replace the existing price schedule with the attached revised price schedule, dated September 16, 2008, listing labor categories, hourly rates, and estimated labor hours, for a total estimated ceiling amount of \$303,863.45. The price schedule columns with shaded gray headings apply to this modification.
4. Replace the original Statement of Work with the attached revised Statement of Work.
5. Add incremental funding in the amount of \$150,000.00, thereby increasing the obligated amount from \$119,724.35 to \$269,724.35.
