Reference Task Order 3, Office of the Nuclear Reactor Regulation (NRR) Systems, under Delivery Order DR-33-07-358.

The purpose of this modification is to correct an error for a funding obligation request in previous Modification No. 4. The obligation amount requested in Modification 4 of \$235,000.00 (Job Code J3223) was an error, and could not be obligated because it was a duplication of the amount of \$31,818.00 (J3223) obligated in Modification 3, plus the amount of \$203,182.00 (J3223) obligated in Modification 4.

Therefore, the duplicate funding request in the amount of \$235,000.00 in Modification 4 is hereby deleted, thereby correcting the obligated amount of this task order from \$2,141,700.00 to \$1,906,700.00.
