ADDITIONAL INFORMATION TO ORDER FOR ADDITIONAL SECURITY MEASURES
(ASMs) AND FINGERPRINTING FOR UNESCORTED ACCESS FOR CERTAIN SPENT
FUEL STORAGE LICENSEES DATED JANUARY 28, 2008

On January 28, 2008, the Nuclear Regulatory Commission (NRC) issued Dominion Energy Kewaunee, Inc. (DEK) Order EA-07-195, "Issuance Of Order For Implementation Of Additional Security Measures And Fingerprinting For Unescorted Access For Certain Spent Fuel Storage Licensees - Kewaunee Power Station Independent Spent Fuel Storage Installation." DEK answered the Order in a February 15, 2008 (Serial No. 08-0039) letter and requested a relaxation of the schedule for the completion of the additional security measures. On July 15, 2008, the NRC granted the relaxation of the Order implementation date to "90 days before the first day that spent fuel is initially placed in the ISFSI," and requested that DEK provide an updated schedule regarding ISFSI completion and proposed initial spent fuel loading.

The current ISFSI schedule is provided in the attachment to this letter. Several operational and construction uncertainties may adversely impact this schedule. DEK will notify the NRC if these uncertainties significantly impact the stated schedule. 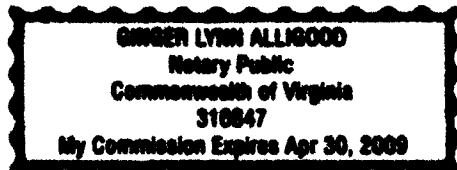
