Reference Task Order 4, Electronic Information Exchange (EIE), under Delivery Order DR-33-07-358.

The purpose of this modification is to (1) add software licenses and maintenance in the amount of \$116,765.40, (2) add estimated travel costs in the amount of \$1,890.00, (3) increase the task order ceiling, and (4) add incremental funding, as follows:

1. The software licenses price, for IBM Lotus Forms Server Processor Value Unit (PVU) License + SW Support 12 Months, Red Hat Developer Professional - Subscription (1 year) - Linux Red Hat, and Red Hat Enterprise Linux – Standard Subscription (1 year) + 1 Year 9x5 Support, is based on the lowest price quotation out of three quotations obtained by OAO Corporation. The quotation, from SHI, is for the amount of \$102,575.00, and is attached. OAO Corporation material handling in the amount of \$5,580.08, Product Line Works (PLW) in the amount of \$1,524.99, and G&A in the amount of \$7,085.33, are added, for a total amount of \$116,765.40.
2. The Nuclear Energy Institute (NEI) has requested NRC's Office of Nuclear Security and Incident Response (NSIR) to present and discuss its new Fitness for Duty (FFD) reporting system which was developed by LMIT under Task Order 4. This presentation will take place in a meeting with the industry which will be held in Las Vegas, Nevada during the period of 14-16 January 2009. Two contractors, Thomas Ryan and Chuck Rybos, who have been involved with the development of the system, will attend the meeting to make the presentation, demonstrate the system's functionality, gather additional requirements, and address questions. The two contractors will travel to Las Vegas on January 14th and will return the evening of the following day. The estimated not-to-exceed cost for the trip to Las Vegas for the two contractors is \$1,890.00.
3. The software licenses and maintenance purchase of \$116,765.40, and estimated not-to-exceed travel costs of \$1,890.00, are Other Direct Costs, and increase the ceiling of Task Order 4 by \$118,655.40, from \$3,623,972.39 to \$3,742,627.79.
4. Incremental funding in the amount of \$200,000.00 (transfer from base order) is added to Task Order 4, thereby increasing the obligated amount from \$2,962,958.41 to \$3,162,958.41.
