
The purpose of this modification is to provide incremental funds in the amount of \$160,000.00, thereby increasing the total obligations from \$360,000.00 to \$520,000.00. Accordingly the contract is modified as follows:

Refer to Section B.4 "Consideration and Obligation -- Cost Reimbursement (Jun 1988)" paragraph (b) is deleted in its entirety and replaced with the following:

"(b) The amount obligated by the Government with respect to this contract is \$520,000.00"

All other terms and conditions remain unchanged.
