Reference Task Order 2, Environment Administration, under Delivery Order DR-33-07-358.

The purpose of this modification is to (1) add hardware and software in the amount of \$35,100.30, (2) increase the task order ceiling, and (3) add incremental funding, as follows:

1. The price for Quad Core Xeon X5460 Processor, and ColdFusion Enterprise 8 Software and Maintenance Agreement, is based on the lowest priced quotation out of three quotations obtained by OAO Corporation. The quotation, from Dell, is for the amount of \$30,681.84, and is attached. OAO Corporation material handling in the amount of \$1,669.09, Product Line Works (PLW) in the amount of \$456.15, and G&A in the amount of \$2,293.21, are added, for a total amount of \$35,100.30.
2. The hardware and software are an Other Direct Cost, and increase the ceiling of Task Order 2 by \$35,100.30, from \$1,620,679.98 to \$1,655,780.28.
3. Incremental funding in the amount of **\$35,100.30** is added to Task Order 2, thereby increasing the obligated amount from \$1,084,310.00 to \$1,119,410.30.
