**Reference:** (1) Letter to John Carlin (Ginna LLC) from Marc Dapas (NRC), Subject: Issuance of Order for Implementation of Additional Security Measures and Fingerprinting for Unescorted Access for R.E. Ginna Nuclear Power Plant Independent Spent Fuel Storage Installation, dated June 3, 2009

On June 3, 2009, the NRC issued Order EA-09-119 (Order) to R.E. Ginna Nuclear Power Plant, LLC (Ginna LLC) regarding additional security requirements for the Ginna Independent Spent Fuel Storage Installation (ISFSI). The Order (Reference 1) imposes requirements to be completed within 180 days from the issuance of the Order.

Ginna LLC consents to the Order with the intent to contain the ISFSI within the Ginna protected area. As such, Ginna LLC will implement the requirements of Attachment 1 to Enclosure 1, section D, of the Order. Additionally, Ginna LLC chooses to comply with the NRC approved reactor access authorization program as described in Attachment 2 to Enclosure 1, section A.2, of the Order. Although Ginna is not currently scheduled to move fuel to the ISFSI until late 2010, the Order's requirements will be implemented by November 30, 2009. Ginna LLC will notify the Commission when the requirements are complete.
