Dear Mr. Brach:

Babcock and Wilcox Nuclear Operations Group, Inc. (B&W NOG) respectfully requests a closed meeting with the appropriate NRC staff to discuss the Request for Additional Information (RAI) for the Model No. UNC-2600 package dated March 13 (Reference 8). After an in-depth review of the RAI and contact with our customer, B&W NOG has determined the continued use of the Model No. UNC-2600 package will be required for shipments and a complete rewritten Safety Analysis Report for Packaging (SARP) may be needed.

As discussed in a teleconference dated June 19, 2009 (Reference 10), B&W NOG would like the opportunity to meet with the NRC to discuss and clarify the use of this package in regards to the RAI. B&W NOG is requesting an afternoon meeting on August 5 or August 6, 2009. The reason for the closed meeting is because the content will include Confidential Restricted Data as defined by the DOE and DOD classification guidance, CG-RN-1.

B&W NOG is providing a tentative date of January 31, 2010 to provide an adequate response to the RAI (Reference 8). This date will be based on the outcome of the closed meeting. If there are any questions in this regard, please contact me at (434) 522-5665.
