The purpose of this modification is to:

1) exercise Option Year Two (September 26, 2009 through September 25, 2010) in accordance with FAR Clause 52.217-9, Option to Extend the Term of the Contract, thereby extending the period of performance through September 25, 2010.

2) increase the amount of the order (ceiling) by \$16,390,201.03, from \$30,709,149.63 to \$47,099,350.66. The ceiling amount of \$47,099,350.66 consists of estimated labor costs of \$45,214,831.67 and estimated other direct costs not-to-exceed \$1,884,518.99.

A letter providing preliminary written notification of the Government's intent to exercise Option Year Two was emailed to OAO Corporation on July 17, 2009.

Accordingly, Section C.29, Duration of Contract, is deleted and replaced with the following:

The ordering period for this contract shall commence on September 26, 2007 and will expire September 25, 2010. Any orders issued during this period shall be completed within the time specified in the order, unless otherwise specified herein. (See 52.216.18 - Ordering). All option periods have been exercised. No option periods remain.

This modification does not obligate any funding.

All other terms and conditions of the subject order remain unchanged.
