The purpose of this modification is to (1) decrease the task order ceiling, (2) revise the price schedule, and (3) add incremental funding, as follows:

1. Decrease the ceiling of this task order by \$450,000.00, from \$1,655,780.28 to \$1,205,780.28.
2. Replace the existing price schedule with the attached revised price schedule, dated July 13, 2009, listing labor categories, hourly rates, and estimated labor hours, for a total ceiling amount of \$1,205,780.28.
3. Add incremental funding in the amount of \$86,369.98, thereby increasing the obligated amount from \$1,119,410.30 to \$1,205,780.28, and fully funding this task order.
