The purpose of this modification is to (1) decrease the task order ceiling, and (2) revise the price schedule, as follows:

1. Decrease the ceiling of this task order by \$13,000.00, from \$37,513.91 to \$24,513.91.
2. Replace the existing price schedule with the attached revised price schedule, dated July 21, 2009, listing labor categories, hourly rates, and estimated labor hours, for a total estimated ceiling amount of \$24,513.91.
