Reference Task Order 2, Environment Administration, under Delivery Order DR-33-07-358.

The purpose of this modification is to add obtain and install the (2) two Air Conditioning units for the two server rooms in the amount of \$98,389.82, and (2) increase the task order ceiling, and increase funding by moving funds from the base contract to this task order, as follows:

1. The price for two (2) Liebert five ton challenger AC units with plenums installed is based on the lowest price quotation out of the three quotations obtained by OAO Corporation. The quotation from Journeyman Mechanical contractors is for \$86,600. OAO Corporation included material and handling in the amount of \$4,711.04, product line works (PLW) charge in the amount of \$1,004.42 and General and Administrative expenses in the amount of \$6,074.36 for a total of \$98,389.82.
2. Increase the ceiling of this task order by \$98,389.82 for replacement of the AC units, from \$1,685,774.39 to \$1,784,164.21. The estimated cost for labor is \$1,639,873.76 and for ODC is \$144,290.45.
3. Transfer \$98,389.82 from the base contract to Task Order 2, thereby increasing the obligated amount from \$1,519,304.81 to \$1,617,694.63.
