

We would like to request relief from occupational dosimetry. Per NUREG-1556 Item 10, we have documentation demonstrating that unmonitored individuals are not likely to receive, in a year, a radiation dose in excess of 10% of the allowable limits in 10 CFR Part 20. We have maintained reports from a NVLAP approved processor for the past 10 years. Upon our review, we have not exceeded the yearly limits.
