The purposes of this modification are the following:

1) Period of Performance

- (b) To incorporate terms and conditions of Option Period 4 which includes T&M labor rates, into Option Period 3, effective on March 26, 2011;
- (c) Rename Option Period 5 as Option Period 4;
- (d) To incorporate a revised ceiling price schedule with revised periods of performance dates.

- (e) The total estimated ceiling is increased from \$1,291,684.71 by \$207,670.12 to \$1,499,354.83.
