Notification of Change in RSO

Dear Ms. Modes:

Pursuant to Item 4.a of the NRC license renewal letter dated January 3, 2006, Tracerco is notifying the NRC of a Radiation Safety Officer change. Due to re-assignment of personnel I assumed the duties of RSO on July 16, 2010. This designation was to be for an interim period until a new Regional Manager/RSO, Ben Zimmerman, was transferred from our Edmonton, AB, Canada office. After my assuming responsibility of RSO and Mr. Zimmerman's re-location to our Newark office, our longtime Edmonton office Regional Manager/site RSO separated from Tracerco. This resulted in a need to re-assign Mr. Zimmerman to our Edmonton office to assume the duties of Regional Manager/Site RSO. Subsequent to the re-assignment of Mr. Zimmerman we will now be designating William Mixon as the RSO for Tracerco's NRC license. I will continue with my responsibilities as Corporate RSO, providing support to Mr. Mixon, and will remain active in the administering of our radiation protection program.

Mr. Mixon is a Chemical Engineer, with fifteen years experience in working with radioactive materials as an employee of Tracerco (formerly Quest Tru-Tec, LP and Tru-Tec Services, Inc) and is very familiar with all aspects of the temporary job site services provided by Tracerco, utilizing various radioisotopes (solids, liquids, gases). 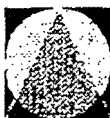



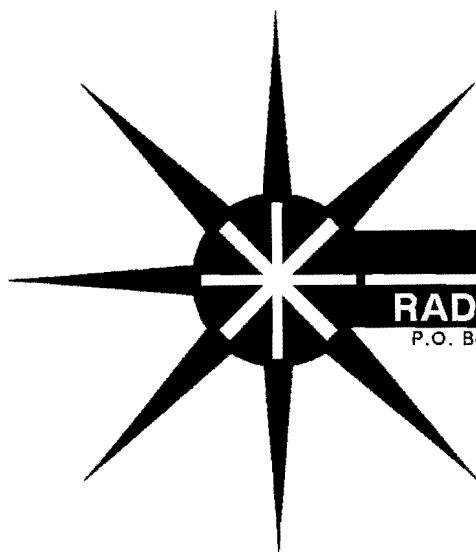
