Dear Michael,

This letter is written to provide additional information and corrections with regards to the Application For Materials License, dated January 11, 2011, filed with the Commission (the "Application").

First, per your request, I am enclosing a statement from Mr. Jerome Russel, the proposed RSO, that he accepts the position and understands its duties and responsibilities.

Next, with regard to your request about the name of AECOM Technical Services, Inc. on the renewal application, as shown below this is not a change of ownership or control as those terms are commonly used.

As background, I understand that the phrase used in the renewal application (that AECOM USA, Inc. and AECOM, Inc. "merged" into AECOM Technical Services) caused some confusion. The individual who prepared the application is not an attorney and inadvertently used this phrase, which often is a term of art.

To be more descriptive, AECOM USA, Inc.; AECOM, Inc. and AECOM Technical Services, Inc. are affiliated entities. As part of an internal corporate reorganization, AECOM USA, Inc. and AECOM, Inc. are now subsidiaries of AECOM Technical Services, Inc., the name on the renewal license. However, we do not believe that this represents a change of ownership or control with regard to the license. For example, as between the current license and the renewal application:

- There has been no change of ownership. All three entities share the same ultimate corporate parent and sole shareholder, AECOM Technology Corporation.
- There has been no change of control. These companies remain under the same common management.
- There has been no change of operations. These companies use the same operating policies and procedures. They also share the same insurance protection and operate from the same locations.

- There has been no change with regard to the use or responsibilities associated with the license. The internal reorganization will not affect the procedures, records handling, facilities where the gauges are located, training programs, decontamination, disposal or emergency plans, financial assurances, documentation, and other commitments previously made that are associated with the license and the gauges at issue. Other than the proposed new RSO, the personnel managing the license from a corporate perspective are the same. AECOM Technical Services is aware and acknowledges that it is abiding by all of the conditions and regulations associated with the license.
