SUBJECT: FINAL RULE – FEE RECOVERY – FISCAL YEAR 2011

A copy of the *Federal Register* notice of final rulemaking, "Revision of Fee Schedules; Fee Recovery for fiscal year (FY) 2011," is enclosed. The notice describes the U.S. Nuclear Regulatory Commission's final amendments to the licensing, inspection and annual fees charged to its applicants and licensees.

It is requested that the Office of Federal and State Materials and Environmental Management Programs notify the Agreement States to distribute this final rule to their licensees. The rule modifies the Part 170 fees currently assessed to those Agreement State licensees who perform work in non-Agreement States under the reciprocity provisions of 10 CFR 150.20. The reciprocity fee will increase from \$1,900 to \$2,300 under the FY 2011 Final Rule.
