Alliance Solution Group (ASG), Inc. is seeking access to records under the Freedom of Information Act and the Privacy Act. ASG is a small, service-disabled, veteran-owned business that offers homeland security solutions to federal, state, and local government agencies as well as private industry.

ASG is currently under contract by the USAF Air Mobility Command to perform Toxic Industrial Chemical (TIC) and Toxic Industrial Materials (TIM) vulnerability assessment at McGuire AFB, Burlington County, in New Jersey. In order to complete the assessment, we need to identify and quantify any information on radioactive materials stored/used within 20 miles of the base. We are requesting information on the companies or businesses that currently have radioactive material licenses/permits within the cities of Manchester, Lakehurst, Jackson, Lacey, Lakewood, Berkeley, Plumstead, East Windsor, Ewing, Hamilton, Hightstown, Lawrence, West Windsor, New Hanover, Wrightstown, Pemberton, Lumberton, Tabernacle, East Hampton, West Hampton, Hainesport, Medford, Medford Lakes, Evesham, Mount Laurel, Mount Holly, Shamong, Woodland, Bordentown, Burlington, Florence, Fieldsboro, Mansfield, Trenton, Riverside, Delran, Moorestown, Delanco, Willingboro, Edgewater Park, Beverly, Chesterfield, North Hanover, South Hampton, Cranbury, East Windsor, Roosevelt, Allentown, Manalapan, Upper Freehold, Morrisville, PA; Tullytown, PA; Pennel, PA; Langhorne, PA; Langhorne Manor; Hulmeville, PA; Bristol, PA; Yardley, PA; Bensalem, PA; Lower Makefield, PA (Monmouth, Middlesex, Ocean, Mercer, Burlington counties in New Jersey and Bucks County in Pennsylvania). If possible, please provide a copy of the license/permit indicating the specific isotope and maximum activity authorized for each item. This information can be provided electronically (CD) if available.
