CRs written related to issues similar to the Fukushima Daiichi Nuclear Station incident should be considered for Significance Level 3, (i.e. Seiche, Flooding, SFP, Earth Quake, SAMG, Tornado, potentially some Security, NRC Temporary Inspection TM-183/184, BDBA, Loss of Offsite power, etc, and related procedure deficiencies). If they are clearly enhancements, the CR could be Sig 4. In either case add PM Review to any CAs, unless decided unnecessary by OR or CRT.
