On behalf of the fuel cycle industry, the Nuclear Energy Institute (NEI)<sup>1</sup> appreciates the time and effort that you and your staff expended to organize and conduct the well received Fuel Cycle Information Exchange (FCIX) held in Rockville, Maryland on June 7 and 8, 2011. In particular, over the last three annual meetings, Ms. Rosemary Reeves has been well organized, responsive, and communicative with industry when working to identify regulatory topics of mutual interest as well as speakers and panelists.

Based on industry feedback during and after the FCIX, it is clear that the program duration, content, speaker presentations, and panel discussions were timely and relevant to industry. 
