The purposes of this modification are the following:

1) Period of Performance

- (a) To extend the period of performance for Option Period 3 by 6 months to September 25, 2011;
- (b) To incorporate terms and conditions of Option Period 4 which includes T&M labor rates, into Option Period 3, effective on March 26, 2011;
- (c) Rename Option Period 5 as Option Period 4;
- (d) To incorporate a revised ceiling price schedule with revised periods of performance dates.
- (e) The total estimated ceiling is increased from \$293,467.94 by \$36,393.00 to \$329,860.94.
