Dear Mr. Keppler:

This is in reply to your letter of March 17, 1975 regarding I & E Bulletin No. 75-03 concerning some problems with ASCO Solenoid Valves.

It has been determined that there are 23 ASCO type 8300C and 8302C Solenoid Valves installed on three safety related systems in the Duane Arnold Energy Center. Twenty-two (22) valves are accessible during power operation. The 23rd valve is inside the drywell and therefore accessible only during hot standby operation.

Conversion kits are being supplied by the manufacturer and will be installed and tested according to their recommendations.

Installation of the conversion kits on the 22 accessible valves will be completed by September 1, 1975. Work on the one valve inside the drywell will be performed at the first occasion consistent with plant operation after receipt of the conversion kits.
